Day-to-Day-Management

Optimum use of human and financial resources, along with the planning, management and control of these resources, is the basic prerequisite for achieving the specified project goals. The main tasks of day-to-day management involve creating, aligning and monitoring the budget, and supporting the project partners in generating reports on schedule. The key areas of this module therefore comprise services aimed at achieving optimum budgeting and cost planning and regular reporting to the partners and the EU.

Quality management

European cooperation projects are complex yet unique undertakings. Systematic quality assurance is a great challenge here. A quality assurance plan and targeted measures for ongoing improvement facilitate the smooth running of project processes. Fraunhofer MOEZ supports the project consortium by creating and implementing a plan of this kind to guarantee efficient time management and smooth internal communication. In this way, delays and content-related challenges can be detected early on and suitable measures can be proposed to minimize problems and optimize project processes.

Research and innovation communication

Communication, reciprocal knowledge transfer and the dissemination of project findings are increasingly gaining significance in EU projects. The aim is to draw widespread attention to research topics, foster the promotion of active cooperation and encourage communication between researchers and a variety of interest groups. Particular focus is on analyzing policy-related practices and topics along with basic conditions at an institutional level, including the formulation of policy-related recommendations for action. This is where Fraunhofer MOEZ's services come in: creating the communication concept, including a project logo and corporate design; developing and running the project website and the internal communication platform; creating targetgroup-specific publications (e.g. policy briefs, studies, flyers and newsletters); organizing and conducting information events, conferences, workshops and online surveys.

Ongoing target-group dialogue

Innovations have to address the specific needs of the individual market players in order to survive in the market. Fraunhofer MOEZ supports its customers in developing new technologies and services in dialogue with the stakeholders, and in successfully establishing them in the market. The Fraunhofer MOEZ approach focuses on the early involvement of the stakeholders particularly in order to avoid time-consuming and expensive undesirable developments that do not meet the needs. It

Access to risk capital and developing innovative financial instruments

In view of the fact that information in the market is often distributed asymmetrically between innovators and investors, Fraunhofer MOEZ offers support in closing funding gaps in the innovation process. Key areas of activity include: expert interviews with national and international investors; conducting transnational events that involve the Fraunhofer network and private investors; the transfer of good-practice examples in the field of innovation funding, and the development of innovative financial instruments
