

# NEW FACES AT THE FRAUNHOFER CENTER



### **Tobias Dauth**

Tobias Dauth officially joined the Fraunhofer Center for International Management and Knowledge Economy on August 1st, 2015. He is taking over management of the units "Entering New Markets" and "Regional Positioning and Location Development". Mr. Dauth studied Business Administration at the University of Applied Sciences in Pforzheim and at the Kelley School of Business in the United States. Following his studies he spent two years at a marketing-oriented management consultancy in Munich (BBDO Consulting, today Batten & Company) but in 2008 returned to the scientific field, beginning his PhD at the Chair of International Management and Strategic Management at ESCP Europe in Berlin. He completed his doctorate in 2012 after which he was promoted to a post-doc position at ESCP Europe. In January 2013, Mr. Dauth accepted a professorship at the Rouen Business School in France. During April 2013 he accepted an appointment at the Leipzig Graduate School of Management (HHL) and has since worked there as an Assistant Professor of International Management.



# **Utz Dornberger**

On August 1, 2015, Professor Dr. Utz Dornberger assumed leadership of the "Knowledge Intensive Services and Development Policy" business unit within the "Knowledge and Technology Transfer" division of the Leipzig Fraunhofer Center. Professor Dornberger, who was born in Weimar in 1970, studied biology at the universities of Jena, Bilbao (Spain) and Paris Du Nord (France), and earned the doctoral designation Dr. rer. nat. (Biochemistry) at the University of Jena. He further completed a Masters in Small Business Studies and graduated from the postgraduate course Small Enterprise Promotion + Training (SEPT) at the University of Leipzig, where he worked as a researcher and lecturer until 2004. Here Professor Dornberger acted as project manager for international research projects in the field of development and promotion strategies for high-tech industries. Since 2004 he has also been the Director in charge of the university's international SEPT program (SEPT - Small Enterprise Promotion and Training). Professor Dornberger is professor of development economics, focusing in particular on small and medium enterprise development. His main activities include analysis, consulting, implementation, training and coaching in the areas of SME promotion and support.
